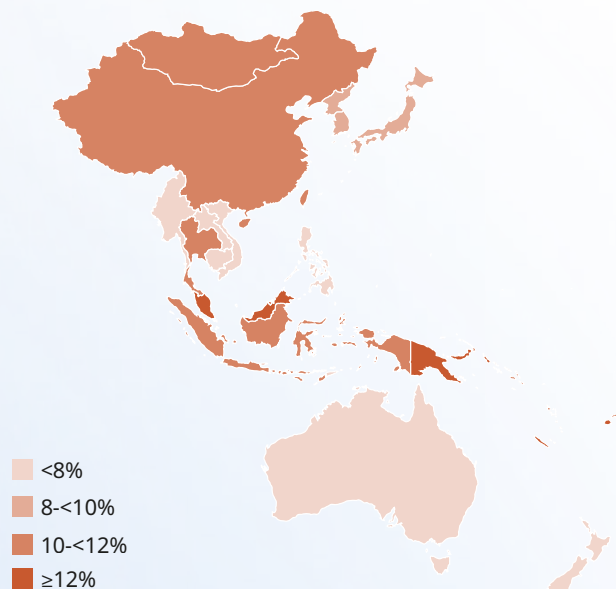


Age-standardised prevalence (%) of diabetes (20-79 years)

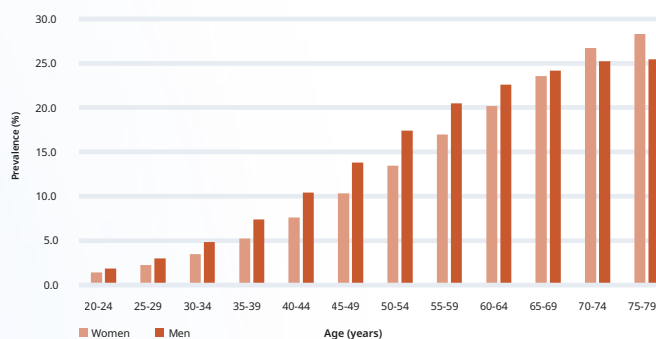

Highlights

- 1 in 8 adults have diabetes – 215 million.
- The Region accounts for over a third (37%) of the total number of adults living with diabetes.
- China accounts for 1 in 4 of all adults living with diabetes worldwide.
- Half (50%) of adults living with diabetes in the Region are undiagnosed.
- Diabetes was responsible for 1.2 million deaths in 2024 – the highest number of all IDF Regions.
- Diabetes-related expenditure in 2024 totals USD 246 billion – 24% of global expenditure.
- 1 in 5 live births are affected by hyperglycaemia in pregnancy.
